
**Adjournment**                    There being no further business, upon a motion by Noah Smith, seconded by Maria Norman, the meeting was adjourned at 6:37 p.m.



Nicholas Devens, community member spoke that he was against masks and that children are treated like dogs as masks are like a muzzle.


