- 60 credit hours: \$110.00
- Bachelor's and above: \$115.00
- Long-term rate; no teaching license: \$150.00
- Long-term rate; with Indiana teacher license: No change (daily contracted teacher rate)

Comments

Board Member Steve Corona assisted a Wayne Graduate in moving to Butler University this past weekend.

Board Member Glenna Jehl thanked principals that welcomed her to the 1st day of school, Jana Ankenbruck, Harris; Nick Sharin, Jefferson; Neil Rupp, Shambaugh. Was reassuring to see all the planning and precautions taken to reopen our schools safely. Commended Dr. Daniel with his community discussions and continuing to communicate with the Board.

Board Member Tom Smith thanked FWCS students staff for their diligence and patience for a successful reopening. Also thanked the Board and administration for working together to purchase education equipment for students, going the extra mile. Board Member Smith also explained that he has received communication inquiring why we do not televise public comments. He is requesting that the Board review the policy on public input at the Board meeting on September 14, 2020.

Board Member Anne Duff visited “first day” of school visits on the two first days of school. She assisted with transportation arm bands at Price and witnessed at another school watching Kindergartners learn how to properly wash their hands. She also assisted with directions at North Side High School.

Board Member Rohli Booker was able to visit elementary schools and was impressed with how the end of the first day of school ended.

Superintendent Daniel reported on how the first few days of school have gone. It is being constantly evaluated and changing as students are still deciding if they will be remote or in-person. We want to meet the needs of both remote and in-person students. After surveying staff, prior to school there was high anxiety, now that school has started, there is less anxiety, but still a stressful time. There will be adjustments. Want to have totally devoted teachers to remote or in-person. Want to continue to provide to our educators time (delay start of school by three days, delay Wednesday) to have continuous training/ opportunity to collaborate and ask questions to become better remote teaching with implementation of strategies. Want to ramp up virtual learning while keeping a safe in-person learning environment. Dr. Daniel thanked the Board, Mary Hess, Charles Cammack to ensure we have nurses and health aides in each building. Needed to start the year so we can make adjustments. Also concerned with social emotional wellbeing of students and staff. Trying to stay in tune and in touch. We have room for improvement, want to hear from teachers. Appreciates everyone’s understanding with this journey. We want realistic expectations, including students being engaged. We may have a future need for more teachers to have a level of excellence with our remote learning.

Board Member Maria Norman asked if we would be surveying parents and Dr. Daniel informed the Board of PTA Zoom meetings. Ms. Norman also reminded families that “technology is great when it works.” There will be FWCS HELP Desk upcoming Tech duty days, check social media for details. She also thanked the FWCS HELP Desk employees.

Next Meeting The next regular meeting of the Board is scheduled for Monday, September 14, 2020 at 6:00 p.m. in the Lester L. Grile Administrative Center.


